Benchmark Assessment A mandatory meeting at which a child's IEP is modified, adjusted, or terminated based on the effectiveness of meeting the child's need.

The practice of periodically checking the success of learning by using a variety of method and practices.

The definition of varies from place to place but typically falls into one of the following categories: Students at-risk of dropping out of school, students with poor academic achievement, and students exhibiting poor attendance.

The demonstration of the acquisition of knowledge through the use of rubrics based on real world exercises and true-life situations.

A student's current level of performance

An expected performance level for a student at a particular point in time determined by standards based criteria; an identified content standard for a particular course, grade level, or developmental level at a specific point in time.

District-wide assessments of students during the school year to monitor progress relative to the standards. They are designed to provide immediate feedback on how students are progressing toward meeting academic standards, as well as to supplement classroom assessments and provide consistency across classrooms and grade levels. Regular use of benchmark assessments is seen by many as a tool to measure student growth and design curriculum to meet student learning needs.

BOE

The Board of Education oversees and manages the community's public school system. It consists of seven trustees who are elected by the community.

Bullying

Bullying is any gesture or written, verbal, electronic, social, graphic, or physical act that is perceived as being dehumanizing, intimidating, hostile, humiliating, threatening or otherwise likely to evoke fear of physical harm or emotional distress. There are four types of bullying: physical, verbal, psychological, and cyberbullying. Bullying may be motivated by (i) bias or prejudice based upon any actual or perceived characteristic, such as race, color, religion, religious practice, ancestry, national origin, weight, ethnic group, socio-economic status, gender, sexual orientation, gender identity or expression; (ii) a mental, physical, or sensory disability or impairment; or (iii) by any other distinguishing characteristic, or is based upon association with another person who has or is perceived to have any distinguishing characteristic.

Family Educational Rights and Privacy Act

(FERPA)

A federal law that affords parents/guardians the right to have access to their children's education records, the right to seek to have the records amended and the right to have some control over the disclosure of personally identifiable information from the education records.

Formative Assessment

Formative assessments are assessments for learning. They are designed to provide information needed to adjust teaching and learning while they are happening. The assessments are used by teachers and students to determine what students have learned in order to plan further instruction.

A planned process that serves a pre-determined

Key Attributes of Formative Assessment Include:

- purpose
 Frequent, ongoing, and evidence-based
- Informs instruction to identify next steps
 Involves students as active participants in assessing their own learning
- Uses growth-producing feedback to support learning
- -Unobtrusive formative assessments are those that do not interrupt the normal flow of activity and are a part of the instructional process; students may not even know they are being assessed.
- -Obtrusive formative assessments interrupt the normal flow of activity in the classroom; however, they are used to diagnose where students are in their learning rather than summarize their progress.

Harassing behavior may based on any characteristic including, but not limited to, a person's

The subjective statement of what is expected to be taught and learned.

The Reading Recovery techniques used for small group targeted reading instruction provided to six or fewer students.

Harassment is the creation of a hostile environment by conduct or by threats, intimidation or abuse that has or would have the effect of unreasonably and substantially interfering with a student's education performance, opportunities or benefits, or mental, emotional, or physical well-being, or conduct, threats, intimidation or abuse that reasonably causes or would reasonably be expected to cause a student to fear for his or her physical safety.

(*Gender identity is one's self-conception as being male or female, as distinguished from actual biological sex or sex assigned at birth. Gender expression is the manner in which a person represents or expresses gender to others, often through behavior, clothing, hairstyles, activities, voice or mannerisms).

Hate Speech

Engaging in conduct that endangers the safety, physical or mental health or welfare of others. Making a slur or statement about any individual or identifiable group of individuals which demeans them because of their race, sex, disability status, age, religion or other protected status and/or which has the foreseeable effect of exposing such persons or group of persons to threats, shame, humiliation, persecution, ostracism. Whether spoken, written, in notebooks, on walls, or on a computer or mobile device, etc., incidents of this type are unprotected speech and will not be tolerated.

Hazing

Hazing is an induction, initiation or membership process involving harassment which produces public humiliation, physical or emotional discomfort, bodily injury or public ridicule or creates a situation where public humiliation, physical or emotional discomfort, bodily injury or public ridicule is likely to occur.

Heterogeneous Grouping

A grouping strategy that does not divide learners into groups based on their ability or learning achievement.

Individuals with Disabilities Education Act – The federal act that regulates and protects individuals with disabilities.

Individualized Education Program: The written plan which specifies the special education programs and services to be provided to a pupil with special needs.

The practice of helping special education students in the least restrictive environment.

An exercise designed for students to independently practice a specific skill.

The practice of teaching to meet the needs, interests, and abilities of each learner.

The legal principle that grants teachers parental-like authority for students while they are in school (e.g., to make and enforce rules or to act on their behalf).

In the temporary removal of a student from the classroom(s) to a designated area in the school building where that student will receive a substantially equivalent, alternative education.

The theme-based approach to instruction that combines subject matter content from various disciplines into one unified course, project, or unit.

Intervention by adults and students in an important step in preventing escalation and resolving issues at the earliest stages. Intervention will emphasize education and skillbuilding. Successful intervention may involve remediation. Remedial responses to bullying, hazing, and harassment include measures designed to correct the problem behavior, prevent future occurrences of such behavior and to protect the target of such behavior. Remediation may be targeted to individual(s) involved in the bullying behavior or may include environmental approaches which are targeted to the building or District as a whole.

The process of using rewards to motivate the student to learn. Intrinsic rewards are found inside the learner, while extrinsic rewards are outside stimuli.

- Training of staff
- Comprehensive school-wide educational component, including character education
- Appropriate supervision of students
- Clear and consistent expectations of behavior
- Use of appropriate interventions when inappropriate conduct occurs

Personnel Action Form

The individual who assists in school under the direction of a licensed professional.

A family member or members and/or the person(s) identified in parental relationship as defined by Educational Law, Section 3212, generally, the primary caregiver(s) of our students.

Professional Development Committee

The body of knowledge concerning the methodology of

teaching.

The measure of an individual's achievement of a given learning

The agreement between two colleagues to work together to better each other's job performance. This consists of

The understanding that words are made up of individual sounds, the ability to distinguish sounds in words, and the

ability to blend sounds together to form words.

The study of sound-symbol (phoneme-grapheme) relationships

as they apply to the teaching of reading in the initial stages.

As part of the PBIS framework, there are six pillars that are focused on character traits of our students that we want to emphasize and encourage. They are: Perseverance,

Communication, Collaboration, Thinkers, Citizenship and Self-

Direction.

A proactive approach to establishing the behavioral supports and social culture that are needed for all students in a school to achieve social, emotional and academic success.

The assessment of achievement at the end of the learning.

Assessments that gather and analyze baseline data about what students know and can do as they enter a learning

experience.

The school setting provides an opportunity to teach children and emphasize among staff, that cooperation with and respect for others is a key value. A district-wide effort geared toward prevention is designed to not only avoid incidents of bullying, but to help students build more supportive relationships with one another by integrating the bullying prevention program into classroom instruction.



Prior Knowledge

The information and concepts classified and stored in long term memory which need to be called up before new

information is imparted.

Professional Development The voluntary, lifelong, continuing program of personal and

professional growth.

Progress Monitoring

The practice of assessing student performance using measures on a repeated basis to determine how well a student is responding to instruction. Data obtained from progress monitoring helps staff to determine the extent to which students are benefiting from instruction and informs decisions

about appropriate levels of intervention.

Physical Therapy

Revenue Anticipation Note

The abbreviation for governmental regulations.

The regulation that requires, where appropriate: speech pathology, audiology, psychological services, physical therapy, occupational therapy, counseling services, parent counseling and training, school health services, school social work, and medical services. The Commissioner's Regulations may also require other appropriate developmental or corrective support

services and appropriate access to recreation.

The SED booklet of practical examples of exemplary Learning

Experiences.

The program which provides supplementary instruction to students. It must not supplant instruction in required subject areas and it cannot be used as course work for diploma credit. There is a class size limit of five students per period, per

teacher.

A process used by educators to help students who are struggling with a skill or lesson; every teacher will use behavior and academic interventions (a set of teaching procedures) with

any student to help them succeed in the classroom/community. **Restorative Practices** Promotes inclusiveness, relationship-building and problemsolving, through restorative methods as circles for teaching

The scoring device used to measure alternative or authentic

SDM-Shared Decision

Making

The process in which representative members of the community and the school, at the district and building levels, work together to identify significant educational issues, define educational goals, plan program strategies, and evaluate program results in order to improve the educational

performance of all students.

Social and Emotional Learning (SEL)

Special Class

The special education program which provides specially designed primary instruction to students in various subject areas as indicated on the IEP. Special class instruction must be provided daily but the number of hours per day may differ according to a student's needs; several class sizes are

possible.

The specially designed services and programs for children with

educational disabilities. **Special Education**

Student Learning Objectives (SLO)

Student Removal

The NYS determined alternative for student growth goalsetting for a teacher for whom there is no state-provided measure of student growth.

The act of a teacher to remove a student from the classroom who engages in a disruptive or violent act in accordance with both the statutory requirements of the District's Code of Conduct. In such cases, the student will be escorted to the designated area and be provided educational programming and activities. Teachers will also immediately report and refer instances of a violent act to the school Principal or Superintendent for violation of the Student Code of Conduct. The administration must then comply with the reporting requirements.

Substantially Disruptive Behavior

An act that is substantially disruptive to the educational process, such that managing the disruption interrupts the educational process and/or an insubordinate action that interferes with or diminishes the authority of school personnel.

Summative Assessment

Summative assessments are assessments of learning. They are designed to document what students have learned at the end of a period of instruction relative to the standards.

Summative Evaluation

The evaluation that provides information that districts use in making the decisions about whether a teacher receives tenure or is terminated.

Superintendent

The Chief Executive Office of Schools or the Superintendent's designee.

Superintendent's Hearing

A hearing by which the Superintendent may suspend a student for longer than five school days. Parents/guardians who disagree with the Superintendent's decision may appeal to the Board of Education, which will make a decision based on the record of the Superintendent's Hearing.

The term used to describe the programs, people and resources that supplement and strengthen the traditional education program for students.

Support Services

School psychologists, school social workers, school counselors, school nurses, occupational therapists, physical therapists, speech therapists, teaching assistants, and teaching aides are all classified as support staff.

Support Staff

Teaching Assistant – an individual who assists a teacher with instructional responsibilities.

TΑ

The non-certified school employee who assists teachers in nonteaching duties, such as record keeping, attending to the physical needs of children, supervising students, and performing other services as determined by the classroom teacher. Teacher aides are governed by the Civil Service Regulations and in the noncompetitive class of Civil Service.

The organizational pattern which groups teachers to work collaboratively in the preparation and presentation of lessons

for students.

Universal Screening

Assessments given to all students at a particular grade level or grade level span for the purpose of identifying students who are not making academic progress at expected rates. It is typically conducted three times per school year, in the fall, winter, and spring and administered to all students.

Upstander

۷I

An upstander is someone willing to stand up and act in defense of others. Further, it identifies people who take helpful steps to help others in instances of bullying, discrimination, harassment or other injustices. Depending on the situation, they help themselves or others by expressing opposition to the bullying and/or by providing emotional support to the target

and/or by getting help for the target.

Violent Act or Behavior

Visually Impaired: The students who may be partially sighted or blind. Their visual disability, even with correction, adversely affects their educational performance.

An action that significantly damages any property, involves procession or use of a weapon or dangerous implement, and/or involves a display or threat made with what appears to be a weapon or dangerous implement capable of causing physical injury or death, or otherwise meets the definition of

violent pupil under New York Education Law Section 3214.

The statement of values, beliefs and expectations which includes both espoused values and values in action.

Financial software program used for accounts payable, payroll,

and human resources.

Norld Languages This term refers to languages other than English that are

taught in school. It replaces the term LOTE.
