

Title I Information for Parents and Families

What is Title I?

Title I is the largest federal aid program for public schools in the United States. It provides federal funds to schools with high percentages of low-income students. These funds pay for extra educational services to help at risk students achieve and succeed regardless of any disadvantages through no fault of their own.

Schools are required to provide supplemental educational services using researched-based strategies to improve student achievement.

All students at the school will be able to benefit from the Title I funding.



How does a school become Title I?

When the number of students eligible for free or reduced lunch prices is greater than the district average, funds are distributed to schools beginning with the highest percentage of free or reduced lunch prices to lowest percentage of free or reduced lunch prices until the funds have been exhausted.



What does it mean to be a Title I School?

Title I Schools receive additional federal funds to supplement the school's existing programs.

These dollars can be used for:

- Identifying students experiencing academic difficulties and providing timely assistance to help these students meet the NYS Standards
- Purchasing supplemental materials and supplies
- Conducting family involvement meetings and activities
- Recruiting/Hiring/Retaining Highly Qualified Teachers
- Sharing parental involvement strategies and rights

As part of this designation, parents have ability to request if child's teacher/teacher aide has adequate certification under the guidelines of New Your State Education Department (NYSED). In particular, you have the right to ask the following questions:

- A. Does my child have a licensed or qualified teacher for the grades and subjects he or she teaches?
- B. Has NYSED decided that the teacher can teach in a classroom without being licensed or qualified under state regulation because of special circumstances?
- C. What is the teacher's college major and do they have any advanced degrees?
- D. What services do paraprofessionals provide to my child (if any) and what are their qualifications?



How is Brockport using Title I funds?

- Intervention teachers and assistants provide supplemental reading and/or math support.
- Varying levels of intervention are based on academic need; accompanied by continual progress monitoring of student achievement



What is the 1% set-aside for Parent & Family Engagement?

- Any district with a Title I allocation exceeding \$500,000 is required by law to set aside 1% of its allocation for parental involvement.
- •The BCSD utilizes these funds to support curriculum information nights, family nights, and/or community engagement events that address the needs of the whole child



What is the Parent & Family Engagement Policy?

- •The BCSD will collaborate with parents and other family members to help students participating in TItle I Programs reach their full academic potential and to improve the District's overall academic quality.
- As part of it's collaboration, the District will conduct outreach; plan and implement programs, activities, and procedures for parent and family member engagement; and consult meaningfully with parents and family Members.




How do I request the qualifications of my child's teachers?
